Waterborne Pre-Catalyzed Lacquer passes KCMA tests with as little as two coats and can be used as a self sealing system. Waterborne Pre-Catalyzed Lacquer is formulated to meet production shop needs and is an excellent environmentally friendly alternative to comparable solvent base pre-catalyzed products. Waterborne Pre-Catalyzed Lacquer may be applied over any Mohawk stain. Note: Allow oil type stains to dry a minimum of 1 hour for improved adhesion. Mohawk's Waterborne Pre-Catalyzed Lacquer is available in plastic single gallon and 5-gallon pail containers, which resist rusting and improve the product's shelf life.

**Directions:** Stir thoroughly before using. Seal with Mohawk Waterborne Pre-Catalyzed Sealer (M640-24007) and allow 30-45 minutes to dry before sanding with 320 grit sandpaper. Waterborne Pre-Catalyzed Lacquer may also be used as its own sealer. Spray Waterborne Pre-Catalyzed Lacquer in full wet coats. NOTES: Protect from freezing. Waterborne Pre-Catalyzed Lacquer is manufactured at spray viscosity. Small amounts of tap water may be used if further reduction is necessary. Do not exceed 5%. Begin with 1 ounce per gallon. Strain product before use for best results. Remove sanding dust after sanding. Stainless steel spray equipment is recommended to avoid iron contamination (discoloration). Flush equipment and fluid lines after use with warm tap water.
